It was brought to our attention by Adam Rubinstein, M.D. that we incorrectly reported to the State Board of Elections the IMPAC Contribution made in April, 2010, by the Medical Staff of Condell Medical Center. That contribution was reported from "Advocate Condell Medical Center," (omitting the reference to the medical staff). We sincerely apologize for this error and have taken steps to correct it.

We have submitted the attached letter to the Illinois State Board of Elections, for filing as an amendment to our D-2 filed in July, 2010 to correct this error. In January, 2011, the laws changed regarding the filing for Political Action Committees and one of the new requirements is quarterly filing of our D-2. That required the software to be re-written, no longer allowing access to the previously filed semi-annual D-2 forms. Because the form is no longer available, we cannot access it to file an amended D-2.

We have worked with the Illinois State Board of Elections and at its suggestion, based on the fact that the semi-annual D-2 form is no longer available, we have submitted the attached letter of explanation as an amendment.

Again, we apologize for any inconvenience that this caused and have taken steps to ensure that the error will not occur in the future.
