**SPRINGFIELD, ILLINOIS, January 5, 2006** – The Illinois State Board of Elections will conduct a campaign disclosure seminar via electronic satellite downlink, Board officials announced today.

At 10:00 a.m. on Saturday, January 14, 2006 the State Board of Elections will simultaneously broadcast a campaign disclosure workshop to twenty sites across the state.

Transmitting from a central location, State campaign disclosure experts will present a detailed program that can conveniently be viewed at any of the twenty locations. The program will include a review of Illinois Campaign Financing Act requirements, recent changes to the law, provide detailed instructions on how to comply with mandated forms and review electronic filing options.

A question and answer session will follow each part of the presentation. If you are not able to attend the seminar in person, it may also be viewed from any computer as a streaming video presentation. Please go to our home page, [www.elections.il.gov](http://www.elections.il.gov) and


click on "Campaign Disclosure." A link will be provided that takes you to the streaming video broadcast.
