Re: Registration of Illinois Coalition for Jobs Growth &
Prosperity Pursuant to 10 ILCS 5/9-7.5

Dear Mr. Borgsmiller:

As you are aware, the provisions of 10 ILCS 5/9-7.5 provide that certain nonprofit entities are required to register with the State Board of Elections, and to file periodic reports.

Our counsel, Andrew M. Raucci, has advised us that the Illinois Coalition for Jobs, Growth & Prosperity may be covered by the provisions of this section. We therefore desire to comply with the provisions of that statute, and to register.

We have also been advised that while the statute provides that "The Board by rule shall prescribe the registration procedure and form", the Board has not done so. We understand that the Board has not prescribed a time for the filing of a registration, but that the statute requires reports to be filed at the same time as the reports required of political committees under the Campaign Disclosure Act.

In an effort to comply fully with the statute, and without the benefit of a form prescribed by rule, we submit the following information in compliance with the requirements of the statute. We are also filing the first report simultaneously in an accompanying letter.


