### Schedule A-1 Contributions

February 26, 2013 Consolidated Primary Election <b>Schedule A-1 Contributions</b>	Contributions, including IN-KIND and LOANS, received within the 30 day period preceding an election of \$1000 or more shall be filed within <b>two</b> business days. This period covers <b>January 27, 2013 through and including February 25, 2013</b> .
April 9, 2013 Consolidated Election <b>Schedule A-1 Contributions</b>	Contributions, including IN-KIND and LOANS, received within the 30 day period preceding an election of \$1000 or more shall be filed within <b>two</b> business days. This period covers <b>March 10, 2013 through and including April 8, 2013</b> .
<b>All other Schedule A-1 Contributions</b>	Contributions, including IN-KIND and LOANS, received at any time other than the 30 day period preceding an election of \$1000 or more shall be filed within <b>five</b> business days. <u><b>Note: Schedule A-1 reporting requirements now apply throughout the calendar year.</b></u>

### Schedule B-1 Independent Expenditures

February 26, 2013 Consolidated Primary Election <b>Schedule B-1 I/Expenditures</b>	Independent expenditures of \$1000 or more made during the period 30 days before an election shall be filed <u>electronically</u> ( <b>Schedule B-1</b> ) within <b>five</b> business days after making the independent expenditure. This period covers: <b>January 27, 2013 through and including February 25, 2013</b> .
April 9, 2013 Consolidated Election <b>Schedule B-1 I/Expenditures</b>	Independent expenditures of \$1000 or more made during the period 30 days before an election shall be filed <u>electronically</u> ( <b>Schedule B-1</b> ) within <b>five</b> business days after making the independent expenditure. This period covers: <b>March 10, 2013 through and including April 8, 2013</b> .

### OTHER REPORTS

#### Form D-1: Statement of Organization

**MUST** be filed within **ten** business days of reaching \$5000 in contributions or expenditures. Committees created in the period 30 days before an election must file a form D-1, Statement of Organization, within **two** business days. **Any** changes to the current D-1 requires an amended D-1 within **ten** days of that change.

#### Raffle Report

A raffle license must be approved by the State Board of Elections PRIOR to the selling of chances. For each raffle conducted, a separate Raffle Report must be filed with the committee's next scheduled D-2 report (see above).
