## ILLINOIS GENERAL ASSEMBLY TERMS

The next two pages provide an alphabetical listing of the names of the 59 Illinois state senators and the 118 Illinois state representatives.

Beginning on page 15, all state senators and state representatives are listed by district, including addresses, telephone numbers, and fax numbers. Each state legislative (senate) district is divided into two state representative districts. The senators are listed in the left column and the representatives are listed in the right column. Also included is the name of the county (or counties) which comprise a legislative district. Senate Districts are divided into three groups and one or two groups are elected every two years. [10 ILCS 5/29C]

Group 1: Elected 2012 and 2016 for 4 years and 2020 for 2 years. District Numbers 1, 4, 7, 10, 13, 16, 19, 22, 25, 28, 31, 34, 37, 40, 43, 46, 49, 52, 55 and 58.

Group 2: Elected 2012 for 4 years, 2016 for 2 years and 2018 for 4 years. District Numbers 2, 5, 8, 11, 14, 17, 20, 23, 26, 29, 32, 35, 38, 41, 44, 47, 50, 53, 56 and 59.

Group 3: Elected 2012 for 2 years, 2014 and 2018 for 4 years. District Numbers 3, 6, 9, 12, 15, 18, 21, 24, 27, 30, 33, 36, 39, 42, 45, 48, 51, 54 and 57.

All 59 senators are elected at the first general election following each decennial redistricting and as shown above. All 118 representatives are elected every two years.
