


Illinois Representative District 101



Representative District 101

(Encompasses the entirety of DeWitt and Piatt Counties, and partially within Champaign, Macon and McLean, Counties):

Representative District 101 shall include that part of Illinois beginning at the northwest corner of Dewitt County (Dewitt County),

thence east along the Dewitt / McLean County border to the southwest corner of Randolph Twp in McLean County,

thence north along the Randolph / Funk's Grove Twp border to E 700 North Rd,

thence east along E 700 North Rd to N 1300 East Rd,

thence south along N 1300 East Rd to E 525 North Rd,

thence east along E 525 North Rd to N 1450 East Rd,

thence south along N 1450 East Rd to E 450 North Rd,

thence east along E 450 North Rd to N 1475 East Rd,

thence south along N 1475 East Rd to E 425 North Rd,

thence east along E 425 North Rd for approximately 800 feet,

thence south for approximately 1120 feet to the north border of Section 28, T22N, R2E (3rd principal meridian),

thence east along the north borders of Sections 28, 27, and 26 T22N, R2E (3rd principal meridian) to E 400 North Rd,

thence continuing east along E 400 North Rd to N 1625 East Rd,

thence north along N 1625 East Rd to E 550 North Rd,

thence east along E 550 North Rd to N 1750 East Rd,

thence north along N 1750 East Rd to E 575 North Rd,

thence east along E 575 North Rd to the Downs Twp border,

thence north along the Downs / Randolph Twp border to the northwest corner of Downs Twp,

thence east along the Downs / Old Town Twp border to the northeast corner of Downs Twp,

thence north along the Old Town / Dawson Twp border to the northwest corner of Dawson Twp,

thence east along the Dawson / Blue Mound Twp border and continuing east along the Martin /

Arrowsmith Twp border and continuing east along the Anchor / Cheney's Grove Twp border to the Ford County border,

thence south along the Ford / McLean County border to the Champaign County border,

thence east along the Ford / Champaign County border to the northeast corner of Ludlow Twp in Champaign County,

thence south along the Ludlow / Harwood Twp border to County Road 3200 N,

thence west along County Road 3200 N to the East Bend Twp border,

thence south along the East Bend / Ludlow Twp border and continuing south along the Rantoul / Condit Twp border to the southeast corner of Condit Twp,

thence west along the Condit / Somer Twp border to the northeast corner of Hensley Twp,

thence south along the Hensley / Somer Twp border to County Road 2000 N,

thence west along County Road 2000 N for approximately 4410 feet,

thence continuing west along the south border of Section 24, T20N, R8E (3rd principal meridian) to N. Prospect Av,

thence continuing west along County Road 2000 N to N. Duncan Rd,

thence south along N. Duncan Rd to W. Bloomington Rd,

thence southeast and south along W. Bloomington Rd to I-57,

thence southwest along I-57 to the Hensley Twp border,
thence west along the Hensley / Champaign Twp border and continuing west along the Scott / Mahomet Twp border to the Piatt County border,
thence south along the Piatt / Champaign County border and continuing south along the Piatt / Douglas County border to the southeast corner of Piatt County,
thence west along the Piatt / Douglas County border and continuing west along the Piatt/ Moultrie County border to the northwest corner of Moultrie County,
thence continuing west along the Long Creek / Mt Zion Twp border to 85th St,
thence south along 85th St to Lehman Rd,
thence west along Lehman Rd to Burgett Dr,
thence north, west and southwest along Burgett Dr to Lehman Rd,
thence west along Lehman Rd to Fort Daniel Rd,
thence north along Fort Daniel Rd for approximately 230 feet to the unnamed creek,
thence southwest approximately 1400 feet along the unnamed creek to Hendricks Ln (extended),
thence east along Hendricks Ln (extended) and continuing east along Hendricks Ln to Fort Daniel Rd,
thence south along Fort Daniel Rd to the entrance road approximately 1150 feet south of Southwind Ln,
thence west, north and west along the entrance road for approximately 680 feet,
thence south for approximately 360 feet,
thence southwest for approximately 8670 feet to CR 60,
thence west along CR 60 to S IL 121,
thence northwest along S IL 121 to Green Valley Dr,
thence south along Green Valley Dr (extended) for approximately 2250 feet,
thence west for approximately 2750 feet,
thence north for approximately 1620 feet,
thence west for approximately 1480 feet to S. Henderson St,
thence south along S. Henderson St to Kraft Rd,
thence west along Kraft Rd for approximately 3000 feet,
thence north for approximately 270 feet,
thence west for approximately 980 feet to Sulphur Spring Rd,
thence south along Sulphur Spring Rd to Hopewell Rd,
thence west along Hopewell Rd to Karl Rd,
thence north along Karl Rd to Hyland Rd,
thence west along Hyland Rd to Walmsley Rd,
thence south along Walmsley Rd to E. Wells Rd,
thence west along E. Wells Rd to Sand Creek,
thence south and west along Sand Creek to Cornthwaite Rd,
thence north along Cornthwaite Rd to Wells Rd,
thence west along Wells Rd to Jacobs Rd,
thence south along Jacobs Rd to the South Macon Twp border,
thence west along the South Macon / South Wheatland Twp border to N. Woodcock Rd,
thence north along N. Woodcock Rd to Craycroft Rd,
thence west along Craycroft Rd to CR 29,
thence north along CR 29 to Moss Rd,
thence west along Moss Rd to the Blue Mound Twp border,
thence north along the Blue Mound / South Wheatland Twp border to the northwest corner of South Wheatland Twp,
thence east along the South Wheatland / Decatur Twp border to the northwest corner of Section 27, T16N, R2E (3rd principal meridian),

thence continuing east along the north border of Section 27, T16N, R2E (3rd principal meridian) to the Decatur Junction rail line,
thence northeast along the Decatur Junction rail line to the Illinois Central rail line,
thence south along the Illinois Central rail line to W. Imboden Dr,
thence east along W. Imboden Dr to S. Franklin St Rd,
thence south along S. Franklin St Rd to E. Imboden Dr,
thence east along E. Imboden Dr to Sandcreek Dr,
thence north along Sandcreek Dr to South Shores Dr,
thence east along South Shores Dr to the South Wheatland Twp border,
thence north approximately 2360 feet along the South Wheatland / Decatur Twp border,
thence east approximately 2280 feet,
thence northeast approximately 390 feet to Lost Bridge Rd E,
thence continuing east along Lost Bridge Rd E and continuing east along E. Maryland St to S. 33rd St,
thence continuing east along E. Maryland St (extended) to S. Albany St,
thence north along S. Albany St to E. Fulton Av,
thence continuing north along S. 36th St to US 36,
thence northwest along US 36 to E. Corman St (extended),
thence east along E. Corman St (extended) and continuing east along E. Corman St to S. 37th St,
thence north along S. 37th St to E. Greenhill Rd,
thence east along E. Greenhill Rd to S. Lake Ridge Av,
thence north along S. Lake Ridge Av to CR 26,
thence northeast along CR 26 to Green Way Ln,
thence northeast and east along Green Way Ln and Greenway Ln (extended) to Robinson Av,
thence north along Robinson Av to Melwood Av,
thence east along Melwood Av to N. Country Club Rd,
thence north along N. Country Club Rd to E. William St Rd,
thence west along E. William St Rd to the Decatur Twp border,
thence north along the Decatur / Long Creek Twp border and continuing north along the Decatur / Oakley Twp border to the Whitmore Twp border,
thence west along the Whitmore / Decatur Twp border to CR 1,
thence north along CR 1 to Ela Industrial Dr,
thence west along Ela Industrial Dr to the Hickory Point Twp border,
thence north along the Hickory Point / Whitmore Twp border to E. Hickory Point Rd,
thence west along E. Hickory Point Rd to US 51,
thence south along US 51 to E. Canterbury Dr,
thence west along E. Canterbury Dr to N. Cambridge Dr,
thence northwest along N. Cambridge Dr and continuing along W. Cambridge Dr to N. Buckingham Dr,
thence southwest along N. Buckingham Dr to Newcastle Dr,
thence northwest along Newcastle Dr to Sheffield Dr,
thence southwest and west along Sheffield Dr to N. MacArthur Rd,
thence south along N. MacArthur Rd to W. Frank Dr,
thence west along W. Frank Dr to N. Arthur Ct,
thence north along N. Arthur Ct to Sarah Dr,
thence west along Sarah Dr for approximately 530 feet,
thence south for approximately 225 feet,
thence west for approximately 925 feet,
thence south for approximately 900 feet,
thence west for approximately 90 feet,

thence south for approximately 125 feet,
thence east for approximately 305 feet,
thence south for approximately 45 feet,
thence east for approximately 300 feet,
thence south for approximately 375 feet to W. Mound Rd,
thence east along W. Mound Rd to N. MacArthur Rd,
thence south along N. MacArthur Rd to W. Karen Dr,
thence east along W. Karen Dr to Nevada Dr,
thence south and east along Nevada Dr to Colorado Dr,
thence south along Colorado Dr to Columbus Dr,
thence west along Columbus Dr to Wisconsin Dr,
thence south along Wisconsin Dr to Northland Dr,
thence southwest along Northland Dr to Wiley Dr,
thence west along Wiley Dr to Greenridge Dr,
thence south along Greenridge Dr to W. Pershing Rd,
thence west along W. Pershing Rd to N. Oakland Av,
thence south along N. Oakland Av to W. Ravina Park Rd,
thence west along W. Ravina Park Rd to N. Dennis Av,
thence south along N. Dennis Av to W. Garfield Av,
thence west along W. Garfield Av to N. Summit Av,
thence north along N. Summit Av to W. Ravina Park Av,
thence west along W. Ravina Park Av to Home Park Av,
thence south along Home Park Av to W. Grandview Dr,
thence west along W. Grandview Dr to N. Florian Av,
thence south along N. Florian Av to W. Olive St,
thence west along W. Olive St to N. Stevens Av,
thence south along N. Stevens Av to W. Hunt St,
thence west and northwest along W. Hunt St and continuing northwest along W. Hunt St (extended) to Stevens Creek,
thence south along Stevens Creek to W. Center St,
thence west along W. Center St to N. Elizabeth St,
thence north along N. Elizabeth St to the Hickory Point Twp border,
thence west along the Hickory Point / Decatur Twp border and continuing west along the Illini / Harristown Twp border to the Niantic Twp border,
thence south along the Niantic / Harristown Twp border to Harristown Rd,
thence west along Harristown Rd to N. Illinois St,
thence south along N. Illinois St to E. Lockhart St,
thence west along E. Lockhart St to N. Broadway St,
thence south along N. Broadway St to the Norfolk Southern rail line,
thence west along the Norfolk Southern rail line to the Sangamon County border,
thence north along the Sangamon / Macon County border to the Logan County border,
thence east and north along the Logan / Macon County border and continuing north along the Logan / Dewitt County border to the point of beginning.
