


Illinois Representative District 69

Representative District 69

(Partially within Boone and Winnebago Counties):

Beginning at the northwest corner of Shirland Twp (the intersection of the Sugar River and the Illinois / Wisconsin border) in Winnebago County,
thence east along the Illinois / Wisconsin border to the northeast corner of Leroy Twp,
thence south along the east borders of Leroy and Boone Twps to the southeast corner of Boone Twp,
thence west along the south border of Boone Twp for approximately 6130 feet, ~~4-15 miles~~,
thence south for approximately 800 feet,
thence west for approximately 3500 feet,
thence north for approximately 800 feet to the south border of Boone Twp,
thence west for approximately 900 feet,
thence south for approximately 800 feet,
thence west for approximately 900 feet,
thence north for approximately 800 feet to the south border of Boone Twp,
thence west for approximately 3500 feet,
thence south for approximately 800 feet,
thence west for approximately 1300 feet,
thence north for approximately 800 feet to the south border of Boone Twp,
thence west along the south borders of Boone and Poplar Grove Twps to the northeast corner of Belvidere Twp,
thence south along the east border of Belvidere Twp to E. 2nd St,
thence west along E. 2nd St to Prospect St,
thence north along Prospect St. to Logan Av,
thence west along Logan Av to Caswell St.,
thence south along Caswell St to E. 4th St,
thence west along E. 4th St to Fremont St,
thence south along Fremont St to E 6th St,
thence south along Fremont St (extended) to Fremont St,
thence continuing south along Fremont St (extended) and Fremont St to Glen Elms Dr,
thence south along Glen Elms Dr to US 20,
thence east along US 20 to Belvidere Rd,
thence south along Belvidere Rd for approximately 200 feet,
thence south /southwest to the east border of Flora Twp,
thence south along the east border of Flora Twp to the southeast corner of Flora Twp,
thence west along the south borders of Flora, Cherry Valley and Rockford Twps to the northbound lane of IL Rt 251 (11th St),
thence northwest for approximately 160 feet to the southbound lane of IL Rt 251 (11th St),
thence south along the southbound lane of IL Rt 251 (11th St) to the Rockford Twp border,
thence west along the Rockford / Scott Twp border to the west border of Rockford Twp,
thence north along the west border of Rockford Twp to the Chicago, Central & Pacific rail line,
thence east along the Chicago, Central & Pacific rail line to Centerville Rd,
thence south along Centerville Rd to Kelley Rd,
thence east along Kelley Rd for approximately 1350 feet,
thence south for approximately 50 feet,
thence east for approximately 1560 feet to Kelley Rd,

thence southeast along Kelley Rd to Montague Rd,
thence northeast along Montague Rd to the southbound On ramp to US 20,
thence south along the On ramp to US 20 and continuing south along US 20 to the east bank of the Rock River,
thence south and west along the east bank of the Rock River to the Kishwaukee River,
thence south along the Kishwaukee River to the former channel of Kilbuck Creek, approximately 3000 feet south of the Rock River,
thence along the former channel of Kilbuck Creek to the northeast corner of Section 28, T43N, R1E,
thence south along the east border of Section 28, T43N, R1E to the southwest corner of the NW ¼, NW1/4 section of Section 27, T43N, R1E,
thence east along the south border of the NW ¼, NW1/4 section of Section 27, T43N, R1E to the southeast corner of the NW ¼, NW1/4 section of Section 27, T43N, R1E,
thence south along the east border of the SW ¼, NW1/4 section of Section 27, T43N, R1E to the northwest corner the NW ¼, SE1/4 section of Section 27, T43N, R1E,
thence south along the east border of the NW ¼, SE1/4 section of Section 27, T43N, R1E to the southeast corner of the NW ¼, SE1/4 section of Section 27, T43N, R1E,
thence east along the south border of the NW ¼, SE1/4 section of Section 27, T43N, R1E to the west border of Section 26, T43N, R1E,
thence south along the west border of Section 26, T43N, R1E, to S. Bend Rd,
thence east along S. Bend Rd for approximately 770 feet,
thence south for approximately 460 feet,
thence east for approximately 660 feet,
thence north for approximately 520 feet to Baxter Rd,
thence east along Baxter Rd for approximately 360 feet,
thence continuing east for approximately 675 feet to the Soo rail line,
thence north along the Soo rail line to Blackhawk Rd,
thence east along Blackhawk Rd to Kirkwood Dr,
thence north and east along Kirkwood Dr to 20th St,
thence north along 20th St to Lookout Dr,
thence east and south along Lookout Dr to Golden Prairie Av,
thence east along Golden Prairie Av to Sonja Ln,
thence south along Sonja Ln to approximately 40 feet north of Olden Oak Dr,
thence east for approximately 1000 feet,
thence north for approximately 200 feet,
thence east for approximately 1750 feet to 35th St,
thence south along 35th St to Blackhawk Rd,
thence east along Blackhawk Rd to approximately 60 feet west of the east border of Section 17, T43N, R2E,
thence north running parallel to the east border of Section 17, T43N, R2E to US 51/I-39,
thence north along US 51/I-39 to the northbound exit ramp to US 20,
thence north on the exit ramp to US20,
thence east on US20 to I-39/US20,
thence northeast on I-39/US20 to I-90,
thence north on I-90 to approximately 75 feet south of the north border of Section 26, T44N, R2E,
thence northwest approximately 465 feet,
thence continuing northwest approximately 1125 feet to the intersection of S. Bell School Rd and the north border of Section 26, T44N, R2E,

thence north along S. Bell School Rd to US20 (E. State St),
thence east along US20 to I-39/I-90/US51.
thence north along I-39/I-90/US51 to a point approximately 770 feet south of the north border of Section 23, T44N, R2E,
thence west for approximately 1400 feet to N Bell School Rd,
thence north on N. Bell School Rd to Golden Rod Ln,
thence west along Golden Rod Ln to Marigold Circle,
thence north along Marigold Circle to Tulip Ln,
thence southwest along Tulip Ln to Centennial Trail,
thence west along Centennial Trail to Fox Chase Ln,
thence south along Fox Chase Ln to Crimson Ridge Rd,
thence west along Crimson Ridge Rd to N. Perryville Rd,
thence north along N. Perryville Rd to Guilford Rd,
thence west along Guilford Rd to N. Mulford Rd,
thence south approximately 2450 feet along N. Mulford Rd,
thence west for approximately 400 feet to the terminus of Donna Rd,
thence south approximately 305 feet along Donna Rd,
thence west approximately 1700 feet,
thence north approximately 260 feet to Inverness Rd,
thence west along Inverness Rd for approximately 250 feet,
thence south for approximately 260 feet,
thence west for approximately 2850 feet to the west border of Section 21, T44N, R2E,
thence north approximately 2600 feet along the west border of Section 21, T44N, R2E to Guilford Rd,
thence east along Guilford Rd for approximately 700 feet,
thence north for approximately 1000 feet,
thence east for approximately 650 feet,
thence north approximately 860 feet to the terminus of Madron Rd,
thence north along Madron Rd to Silverthorn Dr,
thence northeast along Silverthorn Dr to Roanoke Rd,
thence east along Roanoke Rd to Shaw Woods Dr,
thence north along Shaw Woods Dr to Spring Creek Rd,
thence east along Spring Creek Rd to N. Mulford Rd,
thence north along N. Mulford Rd to Spring Brook Rd,
thence east along Spring Brook Rd to N. Perryville Rd,
thence north along N. Perryville Rd for approximately 1800 feet to McFarland Rd,
thence northwest for approximately 140 feet to McFarland Rd,
thence north along McFarland Rd to Rock Valley Pkwy,
thence east along Rock Valley Pkwy to Bell School Rd,
thence north along Bell School Rd to the north border of Section 2, T44N, R2E,
thence east along the north border of Section 2, T44N, R2E to I-39/I-90/US51,
thence north along I-39/I-90/US51 to Harlem Rd,
thence east along Harlem Rd to the Winnebago / Boone County border,
thence north along the Winnebago / Boone County border to W. Lane Rd,
thence west along W. Lane Rd to Belvidere Rd,
thence north/northwest along Belvidere Rd to Swanson Rd,
thence west along Swanson Rd to I-39/I-90/US51,
thence north/northwest along I-39/I-90/US51 to approximately 140 feet north of the south border of Roscoe Twp,

thence west approximately 3950 feet running parallel to the Harlem / Roscoe Twp border,
thence south approximately 2900 feet running parallel to the Roscoe / Owen Twp border,
thence west approximately 3920 feet to the Rock River,
thence generally south west along the Rock River to the south line of the SW $\frac{1}{4}$,NE $\frac{1}{4}$ of Section 7, T45N,
R2E (3rd principal meridian),
thence west approximately 960 feet to Forest Ridge Dr (extended),
thence north along Forest Ridge Dr (extended) and continuing north along Forest Ridge Dr to Gleasman
Rd,
thence west on Gleasman Rd to the Roscoe / Owen Twp line,
thence north along the Roscoe / Owen Twp line to Rockton Twp,
thence west along the Rockton /Owen Twp line to Harrison Township,
thence north along the Harrison / Rockton Twp line to the Pecatonica River / Shirland Twp border,
thence west and north along the Shirland / Harrison Twp border to the point of beginning.
