

thence east to South See-Gwun Ave.,
thence north to West Sunset Rd.,
thence east to South Na Wa Ta Ave.,
thence south to Il. Rt. 58,
thence east to South Mount Prospect Rd.,
thence south to East Thacker St. (Maine Twp.),
thence east, southeast and east following East Thacker St. to South Wolf Rd.,
thence south to Oakwood Ct.,
thence east to South 6th Ave.,
thence south to Hoffman Pky.,
thence east to South 3rd Ave.,
thence north to Oakwood Ave.,
thence east to Graceland Ave.,
thence northeast to the Soo Line RR,
thence southeast following the Soo Line RR to East Algonquin Rd.,
thence east to Center St.,

thence north to Ashland Ave.,
thence east to South River Rd.,
thence southeast to East Walnut Ave.,

thence northeast, north and east following the Des Plaines Corp. limits to I-294,

thence east following US Hwy. 14 to West Dempster St.,
thence continuing east following West Dempster St. to Wisner St.,
thence north to West Dempster St. extended,
thence east following West Dempster St. extended to West Dempster St.,
thence continuing east following West Dempster St. to North Ozark Ave.,
thence south to Greenleaf St.,
thence west to North Ozanam Ave.,
thence south to Il. Rt. 21,
thence southeast following Il Rt. 21 to Main St.,
thence west to North Ozanam Ave.,
thence south to Oakton St.,

thence generally east following Oakton St. to North Oriole Ave.,
thence south to West Howard St.,
thence generally west following West Howard St. to the Maine Twp. line,
thence south, southeast, east, south, east and south following the Maine Twp. line to West Touhy Ave.,
thence generally west following West Touhy Ave. to North Ozanam Ave.,
thence south and southeast following North Ozanam Ave. to North Canfield Rd.,
thence southwest to North Ozanam Ave.,
thence southwest and generally south following North Ozanam Ave. to the Norwood Park Twp. line,
thence generally south following the Norwood Park Twp. line to the Chicago Twp. line (North Canfield Ave.),
thence south and southwest to the Norwood Park Twp. line,
thence generally south following the Norwood Park Twp. line to the Chicago Twp. line,
thence southwest and south to West Berwyn Ave.,
thence west to Pacific Ave.,
thence southwest, west, southwest and southeast following Pacific Ave. to West Foster Ave.,
thence east to North Canfield Ave.,
thence south to the Norwood Park Twp. line (North Canfield Ave.),
thence southeast and generally south following the Norwood Park Twp. line to West Lawrence Ave.,
thence generally west, southwest and west following Lawrence Ave. to the Leyden Twp. line,
thence continuing generally west following the Leyden Twp. line to North East River Rd.,
thence generally north following North East River Rd. to the Leyden Twp. north line,
thence east and south following the Leyden Twp. north line to Carmen Ave.,
thence east to North Delphia Ave.,
thence north to West Foster Ave. (Chicago Twp. line),
thence west to North East River Rd.,
thence northeast, southwest and generally north following North East River Rd. to the Leyden Twp. line (Il. Rt. 72),
thence northwest following Il. Rt. 72 to the Des Plaines River,
thence continuing northwest, north, northeast and northwest following the Des Plaines River to Devon Ave. (Maine Twp.),
thence southwest and generally west following Devon Ave. to Mannheim Rd.,
thence north to Il. Rt. 72,
thence northwest and north following Il. Rt. 72 to the Maine Twp. line,
thence east, north, northwest, west, southwest, south, west and north following the Maine Twp. line to I-90,
thence northwest following I-90 to Il. Rt. 72,
thence west following Il. Rt. 72 to the Maine Twp. line,
thence south, west, northeast, west, north, west, south and west following the Maine Twp. line to the Elk Grove Twp. line,

thence generally south, west, north, west, north, southwest and north following the Elk Grove Twp. line to Old Higgins Rd.,
thence northwest to Il. Rt. 83,
thence northeast following Il Rt. 83 to Touhy Ave.,
thence northwest to Il. Rt. 72,
thence continuing northwest following Il. Rt. 72 to Richard Ln.,
thence northwest and southwest following Richard Ln. to Vera Ln.,
thence west to Busse Rd.,
thence generally north following Busse Rd. to the place of beginning.
