SPRINGFIELD, IL, January 24, 2005 - The Illinois State Board of Elections will conduct a campaign disclosure seminar via electronic satellite hook-up, board officials announced today.

At 10 AM Saturday, February 5, 2005 the State Board of Elections will simultaneously broadcast a campaign disclosure workshop to 11 sites across the state.

Transmitting from a central location, State campaign disclosure experts will present a detailed program that can conveniently be viewed at any of the eleven locations. The program will include a review of Illinois Campaign Financing Act requirements, recent changes to the law, provide detailed instructions on how to comply with mandated forms and review electronic filing options.

A question and answer session will follow each part of the presentation.

With February 7th is the deadline for filing the Pre-Election Report of Campaign Contributions and Expenditures for the Consolidated Primary Election quickly approaching, board officials urge campaign workers, officers, and candidates to take advantage of this opportunity and attend the nearest location.

The Seminar, which is free and requires no pre-registration, will last approximately two hours. A listing of locations follows.
