The meeting is scheduled to begin at 10:30 a.m. in the Board's principal office located at 1020 South Spring Street, Springfield, IL. The meeting may be monitored in the Board's Chicago office located in the James R. Thompson Center, Suite 14-100, 100 West Randolph Street, Chicago, IL.
