
### TASK FORCE PUBLIC HEARING & MEETING

Pursuant to Public Act 96-832 (SB 1466), the Campaign Finance Reform Special Task Force will conduct a public hearing on Monday, April 22, 2013.

The Public Hearing is scheduled to begin at 1:00 p.m. in Room 16-503, 100 W. Randolph Street, Chicago, IL. Immediately after the conclusion of the Public Hearing, the Task Force will convene a meeting located in Suite 14-100 and via video conference in the State Board of Election's principal office located at 2329 S. MacArthur Blvd., Springfield, IL. Attendance at the Thompson Center requires security screening and government issued state identification.

The Campaign Finance Reform Special Task Force will examine the feasibility of public financing of election campaigns and will examine the impact of the new contribution limits which went into effect January 1, 2011. The Task Force will make recommendations by December 31, 2011 and September 30, 2012 respectively and issue a final report by March 10, 2015. The Task Force will also file recommendations and a report by February 1, 2013 dealing with laws regarding independent expenditures and their effect on the 2012 primary and general elections.
