PUBLIC NOTICE OF STATE BOARD OF ELECTIONS MEETING

The Illinois State Board of Elections will conduct its regularly scheduled monthly Board Meeting on **MONDAY, JULY 11, 2016**.

The meeting will begin at 10:30 a.m. in the Board's principal office located at 2329 S. MacArthur Boulevard, Springfield, IL and via videoconference in Suite 14-100 of the James R. 
