The next item on the agenda was to approve the Rules of Procedure. Member Smart moved the Rules be approved and seconded by Member Brady. Member Porter had some concerns about the language in Item Number Four where it gives the Chairman of the Board and a Member of the Board designated by the Chairman or hearing examiner to preside at such hearings. The General Counsel commented that he did not think a Chairman of the Board in the past had presided over a meeting or designated another person to do so and offered to adjust the language to take into account Member Porter's concerns. After discussion it was agreed to amend that portion of the Rules by striking "The Chairman of the Board, a Member of the Board designated by the Chairman or the" and insert "if a hearing examiner is appointed" and that sentence will read "if a hearing examiner is appointed, the hearing examiner shall preside over all such hearings." Members Smart and Brady agreed to the amendment and the motion passed by roll call vote of 8-0.

Member Keith moved to appoint the hearing officers as recommend by the General Counsel. In the case there is a recusal of any hearing officer, the General Counsel has the authority to appoint a replacement hearing officer on the list of appointed hearing officers. Member Smart seconded the motion which passed by roll call vote of 8-0.

The General Counsel reported on *Kvernes v. Schorfheide*, 10SOEBGE102 and indicated the candidate filed a withdrawal of candidacy which rendered the objection moot. Andrew Finko, attorney for the objector and Michael Kasper, attorney for the candidate both concurred.

With there being no further business before the State Officers Electoral Board Member Brady moved to recess until the call of the Chairman. Member McGuffage seconded the motion which passed unanimously. The meeting recessed at 3:15 p.m.


The special meeting of the State Officers Electoral Board was called to order via videoconference means at 10:30 a.m. with all Members present. The General Counsel updated the Board on the status of the records examination. He indicated that one was completed and the second nine records examinations were being conducted at this time.
