
The Board will convene as the State Officers Electoral Board to consider objections to independent and new party candidate nominating petitions for the November 8, 2016 General Election:

The Board may address other matters as needed and/or recess into executive session to address pending litigation, complaints following closed hearing and/or personnel matters.
