## INSTRUCTIONS FOR COMPLETION OF THIS INDEPENDENT EXPENDITURE DISCLOSURE FORM

### SEE PAMPHLET "A GUIDE TO CAMPAIGN DISCLOSURE" FOR ADDITIONAL GUIDANCE.

1. Enter the Independent Expenditure Committee's name.
2. Enter the Independent Expenditure Committee's complete address.
3. Enter the name of the candidate or public official for whom the independent expenditures were made on behalf of or in opposition to.
4. Check the column that indicates whether the Independent Expenditure Committee 'supported' or 'opposed' the candidate or public official.
5. Enter the date the independent expenditure was made.
6. Enter the total amount of the independent expenditure on the date indicated.
7. Enter the nature or purpose of the independent expenditure.
8. **Sign and date the form.**

According to Section 9-8(h-5), if an Independent Expenditure committee makes independent expenditures in support of or opposition to the campaign of a particular public official or candidate in an aggregate amount of more than (i) \$250,000 for statewide office or (ii) \$ 100,000 for all other elective offices in an election cycle, as reported in this disclosure, then the Board shall give notice to each candidate for the same office as the public official or candidate for whose benefit the independent expenditures were made. Upon receipt of this notice, all candidates for that office in that election, including the public official or candidate for whose benefit the independent expenditures were made, shall be permitted to accept contributions in excess of any contribution limits.
