

# NATURAL PERSON INDEPENDENT EXPENDITURE DISCLOSURE

A natural person shall notify the State Board of Elections of an aggregate of independent expenditures supporting or opposing a public official or candidate totaling \$3000 or more during any 12 month period, within 2 business days of meeting/exceeding the \$3000 threshold; additional expenditures in increments of \$1000 in relation to same election must also be reported.

Using this same form, when a natural person makes an independent expenditure(s) supporting or opposing a single public official or candidate during an election cycle aggregating more than (i) \$250,000 for statewide office or (ii) \$100,000 for all other elective offices, he/she must notify the Board of Elections by filing this form within 2 business days. This shall result in the lifting of all contribution limits for each candidate for that office.

# INSTRUCTIONS FOR COMPLETION OF THIS NATURAL PERSON INDEPENDENT EXPENDITURE DISCLOSURE FORM

## SEE PAMPHLET "A GUIDE TO CAMPAIGN DISCLOSURE" FOR ADDITIONAL GUIDANCE.

1. Enter the natural person's name.
2. Enter the natural person's complete address.
3. Enter the natural person's occupation.
4. Enter the name of the natural person's employer.
5. Enter the name of the candidate or public official for whom the natural person made an independent expenditure on behalf of or in opposition to.
6. Check the column that indicates whether the natural person 'supported' or 'opposed' the candidate or public official.
7. Enter the date the independent expenditure was made.
8. Enter the total amount of the independent expenditure on the date indicated.
9. Enter the nature or purpose of the independent expenditure.
10. **Sign and date the form.**

According to Section 9-8(h-5), if a natural person makes independent expenditures in support of or opposition to the campaign of a particular public official or candidate in an aggregate amount of more than (i) \$250,000 for statewide office or (ii) \$ 100,000 for all other elective offices in an election cycle, as reported in these disclosures, then the Board shall give notice to each candidate for the same office as the public official or candidate for whose benefit the natural person made independent expenditures. Upon receipt of this notice, all candidates for that office in that election, including the public official or candidate for whose benefit the natural person made independent expenditures, shall be permitted to accept contributions in excess of any contribution limits.
