ILLINOIS GENERAL ASSEMBLY

The next two pages provide an alphabetical listing of the names of the 59 Illinois state senators and the 118 Illinois state representatives.

Beginning on page 12, all state senators and state representatives are listed by district, including addresses, telephone numbers, fax numbers and e-mail addresses (if available). Each state legislative (senate) district is divided into two state representative districts. The senators are listed in the left column and the representatives are listed in the right column. Also included is the name of the county (or counties) which comprise a legislative district. Senate Districts are divided into three groups and one or two groups are elected every two years.

Group 1: Elected 2002 and 2006 for 4 years and 2010 for 2 years. District Numbers 1, 4, 7, 10, 13, 16, 19, 22, 25, 28, 31, 34, 37, 40, 43, 46, 49, 52, 55 and 58.

Group 2: Elected 2002 for 4 years, 2006 for 2 years and 2008 for 4 years. District Numbers 3, 6, 9, 12, 15, 18, 21, 24, 27, 30, 33, 36, 39, 42, 45, 48, 51, 54, and 57.

Group 3: Elected 2002 for 2 years, 2004 and 2008 for 4 years. District Numbers 2, 5, 8, 11, 14, 17, 20, 23, 26, 29, 32, 35, 38, 41, 44, 47, 50, 53, 56, and 59.

All 59 senators are elected at the first general election following each decennial redistricting and as shown above. All 118 representatives are elected every two years.

COURTS IN ILLINOIS

The Supreme Court has seven justices elected from judicial districts for a term of ten years. Three justices are elected from the First District (Cook County), and one justice is elected from each of the other four districts. A Chief Justice (selected from their number) serves for a term of three years.

The Appellate Court has five districts and judges are elected for a term of ten years. The First District (Cook County) has 18 elected judges. The remaining 101 downstate counties are divided into four districts; each downstate district elects six judges.

The Circuit Court is comprised of Circuit Judges and Associate Judges. Circuit Judges are elected for a term of six years; Associate Judges are appointed by the Circuit Judges for four year terms. There are 22 judicial circuits in Illinois. The Cook County Judicial Circuit is an unnumbered circuit. In addition to the circuit judges that are elected at large they have 15 subcircuits.

Candidates for elective judgeships are nominated at the Primary Election and elected at the General Election. At the expiration of a term, a previously elected judge may seek to be retained in office for another term. The judge's name is placed on a special judicial ballot and submitted to the voters. Votes are cast based solely on the question of whether the judge shall be retained and without party designation or an opposing candidate.
