PREFACE

COURTS IN ILLINOIS

Candidates for elective judgeships are nominated at the Primary Election and elected at the General Election. At the expiration of a term, a previously elected judge may seek to be retained in office for another term. The judge's name is then placed on the ballot at the General Election. Votes are cast based solely on the question of whether the judge shall be retained or not, and without party designation or an opposing candidate.

The Supreme Court has seven justices elected from judicial districts for a term of ten years. Three justices are elected from the first district (Cook County) and one justice is elected from each of the other four districts. A Chief Justice (selected from their number) serves for a term of three years.

The Appellate Court has five districts and judges are elected for a term of ten years. The first district (Cook County) has 18 elected judges. The remaining 101 downstate counties are divided into four districts where each district elects six judges.

The Circuit Court is comprised of Circuit Judges and Associate Judges. Circuit Judges are elected for a term of six years and Associate Judges are appointed by the Circuit Judges for four year terms. There are 23 judicial circuits in Illinois. The Cook County Judicial Circuit is an unnumbered circuit and in addition to the circuit judges that are elected at large they have 15 subcircuits. For each judicial circuit district, there are resident circuit judges under their corresponding counties.

QUESTIONS

This publication is created by the State Board of Elections and updated in conjunction with information obtained by the Administrative Office of the Illinois Courts. For questions relating to running for a judicial office, judicial vacancies and the election/nomination of judges, contact the Illinois State Board of Elections. For questions regarding what district to run in and questions regarding other judgeships, contact the Illinois Courts.
