Thanks to the hard work of Illinois election officials, the earliest primary election in Illinois history was one of the most successful in history. A record 2,986,982 voters turned out for the presidential primary and early voting was a tremendous success.

2008 IMPORTANT DATES

- * Monday, May 5 - Last day to file petitions with the Secretary of State to amend Article IV of the State Constitution (None filed)
- * Monday, May 19 - Advisory Committee (9:30 a.m.) and Board meeting (10:30 a.m.) Springfield
- * Monday, June 9 - Board meeting (10:30 a.m.) Chicago
- * June 16-23 Filing period for nomination papers for independent candidates and new political party candidates who file for federal, judicial, state or county offices
- * July 2, 2008 - Last day lottery shall be conducted when 2 or more petitions are received simultaneously for the same office by more than one new political party, nonpartisan, or for independent candidates
- * Friday, August 29 - Board meeting (10:30 a.m.) Chicago - Certification of candidates. Note: Nominees for Republican Party for President and Vice President will not be certified until chosen by the national nominating convention scheduled for September 1, 2008.
- * Monday, September 15 - Advisory Committee Meeting (9:30 a.m.) and Board meeting (10:30 a.m.) Springfield

HAVA FUNDING UPDATE

Current grants available to all jurisdictions

Phase II -- available until **November 2008** (all paperwork must be submitted by December 31, 2008 - Can be used to meet the requirements of Title III

VAID II -- available until **November 2008** (all paperwork must be submitted by December 31, 2008 - Can be used for polling place accessibility only, including accessible voting equipment

The State Board of Elections will be updating the State Plan in order to request FY 08 federal funding of HAVA requirements funds. These funds will be dependent upon the SBE receiving state matching funds as required by HAVA..

Additional Health & Human Services (accessibility) funds (FY 08) will be made available to states as well.

ELECTIONS

The State Board of Elections' Division of Election Training and Resource Development processed 9,281 voter registration application transmittals to the election authorities in 2006; 9,149 application transmittals in 2007; and as of April, 16,175 application transmittals already for 2008! Interest in the Presidential election appears to be high!

The Mock Election programs are available on the SBE website under the Voting and Elections front page link. Both the K-3 Let's Vote and the 4-12 Mock Election programs will be updated after candidate certification to include the names of the actual candidates running for certain offices as indicated in the books.

The LEO Handbook, the 2009 Candidates Guide and 2009 Township Caucus Guide are expected to be ready and distributed sometime in July 2008. These are available under the Voting and Elections front page link.

The 2009 Election & Campaign Finance Calendar will be completed by the end of July and will also be available under the Voting and Elections front page link.

The Election Authorities Guidelines for 2008 publication may be ready in July, pending legislative changes.
