
Illinois Representative District 14



Representative District 14

(Entirely within Cook County):

Representative District 14 shall include that part of Illinois

beginning at the intersection of Dewey Av (extended) and the CTA rail line in Evanston, Cook County, thence east along the CTA rail line to Barton Av (extended),

thence north along Barton Av (extended) and continuing north along Barton Av to Harvard Terrace,

thence east along Harvard Terrace to Ridge Av,

thence north along Ridge Av to Mulford St,

thence east along Mulford St for approximately 200 feet to the alley between Ridge Av and Elmwood Av,

thence south along the alley between Ridge Av and Elmwood Av to Case St,

thence east along Case St to Custer Av,

thence south along Custer Av to the CTA rail line,

thence east along the CTA rail line to Chicago Av,

thence north along Chicago Av for approximately 570 feet to the south border of Calvary Cemetery,

thence east along the south border of Calvary Cemetery to the Lake Michigan shoreline,

thence south along the Lake Michigan shoreline to W. Foster Av (extended),

thence west along W. Foster Av (extended) to W. Foster Av,

thence west along W. Foster Av for approximately 600 feet to a point approximately 120 feet east of N. Marine Dr,

thence northwest to the east terminus of W. Berwyn Av,

thence west along W. Berwyn Av to N. Sheridan Rd,

thence south along N. Sheridan Rd to W. Foster Av,

thence west along W. Foster Av to the CTA rail line,

thence south along the CTA rail line to W. Winona St,

thence west along W. Winona St to N. Broadway St,

thence North along N. Broadway St to W. Foster Av,

thence west along W. Foster Av to N. Clark St,

thence north along N. Clark St to W. Catalpa Av,

thence east along W. Catalpa Av for approximately 150 feet to the alley between N. Clark St and N.

Glenwood Av,

thence north along the alley between N. Clark St and N. Glenwood Av to W. Gregory St,

thence west along W. Gregory St to N. Clark St,

thence north along N. Clark St to W. Hood St,

thence east along W. Hood St to N. Greenview Av,

thence north along N. Greenview Av to W. Granville Av,

thence east along W. Granville Av to N. Glenwood Av,

thence north along N. Glenwood Av to W. Rosemont Av,

thence west along W. Rosemont Av to N. Greenview Av,

thence north along N. Greenview Av to W. Highland Av,

thence west along W. Highland Av to N. Clark St,

thence north along N. Clark St to W. Devon Av,

thence west along W. Devon Av for approximately 200 feet to the alley between N. Clark St and N. Paulina St,

thence north along the alley between N. Clark St and N. Paulina St to W. Schreiber Av,

thence west along W. Schreiber Av to N. Ravenswood Av,

thence south along N. Ravenswood Av to W. Devon Av, thence west along W. Devon Av to N. Ridge Blvd, thence north along N. Ridge Blvd to W. Touhy Av, thence west along W. Touhy Av to N. Western Av, thence north along N. Western Av to Howard St, thence west along Howard St to Dewey Av, thence north along Dewey Av to the point of beginning.
